The term of this contract shall be from _____ until verbal or written notice by client and or The Traveling Companion. Client authorizes this signed contract to be valid approval for future services, without the necessity of additional signed contracts or written instructions.

Future reservations:

Future care arrangements may be made by telephone or email reservation. Please allow at least 4 days advance notice to request future services. Please book holiday and summer reservations early to guarantee availability. To secure dates, payment must be made in advance.

Authorizations:

I, _____ authorize The Traveling Companion to care for my pet(s) while I am gone. The Traveling Companion is entrusted to use their best judgment in caring for my pet(s), under both normal conditions, and in the event of abnormal conditions, such as inclement weather or natural disaster. The Traveling Companion will be held harmless for consequences related to such decisions. The Traveling Companion agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, I expressly waive and relinquish any and all claims against The Traveling Companion except those arising from negligence or willful misconduct.

I, _____ authorize The Traveling Companion to transport my pet(s) to my veterinarian (or one that is close/available) in the event of illness/injury, and to approve medical or emergency treatment deemed necessary by a veterinarian. In the event that the pet requires hospitalization, The Traveling Companion is authorized to leave the pet(s) at the veterinary clinic until the pet(s) can be transported to her home. If The Traveling Companion incurs veterinary expenses on behalf of my pet(s), I agree to promptly reimburse for that amount. If at-home medication is prescribed, The Traveling Companion has my permission to administer the directed dosages. The Traveling Companion shall be released from all liabilities related to transportation, treatment and expense.

Payment For Services:

I understand that this contract also serves as an invoice and that I agree to make full payment to The Traveling Companion prior to departure, for the initial trip and any future trips. Payment for services will be provided at the agreed up rates of:

I acknowledge that full payment must be made in advance of agreed upon trips in order to confirm and secure dates. Payments can be made by cash or check. A handling fee of \$30 will be charged on all returned checks. A finance charge of 1.5%/month will be added to unpaid balances after 30 days. In the event it becomes necessary to initiate collection proceedings, I understand that I will be responsible for all attorneys' fees and cost of collection. I understand that rates for subsequent services may be subject to change.

Cancellation Policy:

I agree to give at least 48 hours notice except in the case of an emergency. If less than 48 hours notice is given, I understand and agree that I am responsible for the first day's fee. If proper cancellation notice is given, all fees previously collected will be credited towards my next service. I understand that there are no refunds.

Visits to my home:

If The Traveling Companion is contracted to make visits to my home to care for my pet(s), she agrees to provide all agreed upon services in a reliable, caring and trustworthy manner. The Traveling Companion shall hold the key/code/access to my residence in complete privacy and will store keys in a secure environment, not identifiable to any person other than herself. I understand that The Traveling Companion will not be held responsible or liable for damages or circumstances beyond her control.

I must disclose all characteristics and habits of my pet(s) during our initial consultation.

If any other person(s) have access to my property, premises, residence or pet(s) during the contracted date of services, I release The Traveling Companion from any and all claims arising during those dates.

I understand and acknowledge that if my pet(s) have access to the public streets (during dog walks, for example), I cannot hold The Traveling Companion responsible for injury, disappearance, death or fines of pet(s).

It is expressly understood that I must contact The Traveling Companion immediately upon returning home (email or voicemail message). If I do not notify The Traveling Companion by email or voicemail, she will continue to make visits to my home to care for my pet(s), and I will be responsible for additional visit fees, even if I have returned home in the meantime. If I am delayed from returning home, I must contact The Traveling Companion to notify her of the situation and make arrangements for an extension to the services. I understand that I am responsible for additional fees for extended services.

Boarding

If The Traveling Companion is boarding my pet(s) in her private residence, she agrees to provide all agreed upon services in a reliable, caring and trustworthy manner. She agrees to follow specified feeding and medication schedules.

I must disclose all characteristics and habits of my pet(s) during our initial consultation.

If my pet(s) cause damage or loss to The Traveling Companion's residence, properties, garden, etc,...I understand that I am obligated to reimburse The Traveling Companion for any/all replacement values, upon being presented with an itemized list when I return to pick up my pet(s). I understand that The Traveling Companion is boarding my pet in her own private residence, and that my pet(s) must not be an excessive barker. If at any time, The Traveling Companion feels that my pet(s) behaviors are not acceptable, (unrestrained barking, damage to properties, aggression towards other animals or humans), it is expressly understood that The Traveling Companion reserves the right to have my pet(s) kenneled and that I am responsible for any and all kennel fees thereof.

I understand that a doggie-social environment may involve play that results in unintentional injury to my pet(s). I acknowledge that The Traveling Companion provides a secure and safe environment, and will not be held responsible for injuries that occur outside of her direct control.

Cats will be boarded in a separate room, safe and secure, away from dogs. Client to furnish litter box, scoop, clump litter, and food for duration of boarding time.

Dog Walks

I understand and acknowledge any and all risks involved with walking a dog on public streets. I agree to sole liability for any acts/behaviors of my pet(s) toward any animals/people while in the care of The Traveling Companion's walking services. I understand and acknowledge that if my pet(s) have access to the public streets (I cannot hold The Traveling Companion responsible for injury, disappearance, death or pet fines incurred.

I agree to provide The Traveling Companion with a 6' leash, appropriate sized choke chain and/or pinch collar and/or gentle leader. The pet(s) collar must have current ID tags with an owner's name and phone number.

Biting and Aggression:

The Traveling Companion reserves the right to terminate this service agreement at any time before or during its term if The Traveling Companion, in her sole discretion, determines that my pet(s) pose a danger to her health or safety. If concerns prohibit The Traveling Companion from caring for my pet(s), I authorize the pet(s) to be placed in a kennel, with all charges there from to be my responsibility.

If my pet(s) has a history of biting or aggression, The Traveling Companion reserves the right to refuse service. In the event that my pet(s) bites The Traveling Companion, another human being or

another animal, The Traveling Companion is required by law to report the incident to the authorities. I shall be liable for any medical care, expenses or damages that result to The Traveling Companion, others or other animals.

Final notes:

The Traveling Companion is committed to providing excellence in loving and professional care to your pet(s) while they are under her umbrella of responsibility. However, due to the extreme unpredictability of animals, The Traveling Companion cannot accept responsibility for any mishaps of any extraordinary or unusual nature, (i.e. , biting, accidental death, allergies, fines or citations, disappearance, injury, complications that might arise when administering medications, etc.)
